2017: THE NEW INCOME TAX THRESHOLD Explained

New **Income Tax Threshold Explained**

The effective income tax threshold for 2017 will come into effect as of January 2017 and will increase by \$250,068 over 2016 for the first three months of the year (Jan.-Mar.), with a further increase of \$1,125,072 for the remaining nine (9) months (Sept.-Dec.) of 2017 making the total tax threshold \$1,375,140. This means that individuals earning \$1,375,140 or less in 2017 will pay no taxes, while those earning above the threshold will have the threshold amount deducted before the tax rate is applied.

Below is an example of how net pay is calculated after taxes and the threshold is applied.

The final addition to the tax threshold will take effect in January 2018 at which time the full impact of the \$1,500,096 will be realised with the addition of \$125,008 to the 2017 threshold of \$1,375,140 totalling \$1,500,096 to which no taxes will be applied.
